Instructions for Candidates:

Candidate will have to fill fresh preferences for Round 2 and 3 respectively as per the schedule. The preference filled will be considered only for that round and will be null & void for subsequent rounds.

Eligibility for CAP-2

- 1) Registered candidates who did not fill choices in Round -1.
- 2) Registered candidates who participated in Round1 but did not get any seat allotted in Round -1.
- 3) Registered candidates, whose seat allotted in Round got cancelled during the document verification due to his/her invalid/wrong claim on reporting for admission to the selected Institute, but candidate is otherwise eligible for selection with change in the invalid/wrong claim. For such a candidate, selection during first round will not be valid and he/she will be eligible only on available seats during subsequent round with corrected claim.
- 4) Candidates who have reported/joined at allotted institute during the joining period of Round-1 of allotment and did not filled Status Retention Form.

Eligibility for CAP-3

- 1) Registered candidates who did not fill choices in Round-1 & Round-2.
- 2) Candidates who are joined in Round-2 but did not filled Status Retention Form.
- 3) Registered candidates who participated in Round-1 & Round-2 but did not get any seat allotted in Roun-1 & Round-2.
- 4) Registered candidates, whose seat allotted in Round got cancelled during the document verification due to his/her invalid/wrong claim on reporting for admission to the selected Institute, but candidate is otherwise eligible for selection with change in the invalid/wrong claim. For such a candidate, selection during first round will not be valid and he/she will be eligible only on available seats during subsequent round with corrected claim

Not eligible for CAP-2 & CAP-3

- 1) Candidates who have joined previous allotted seat and filled Status Retention Form.
- 2) Candidates who have not filled fresh preferences for that round as per the schedule.
